A grateful St. Francis patient *uses her experiences as a survivor to give back*

In October 2006, Rhonda Zweber had her annual mammogram at St. Francis Regional Medical Center. The results were normal. So, when the 42-year-old mother of three girls and former physical education teacher discovered a lump during a self-breast examination the following April, she thought she'd keep an eye on it and monitor it herself.

On Mother's Day, she met some friends to walk the Susan G. Komen Race for the Cure. When she mentioned to her friends that she had discovered a lump, they almost froze in their tracks. "One friend told me that early detection had saved her life," says Zweber. "She encouraged me to get in and have it checked out immediately." She called St. Francis the next week and underwent a mammogram, ultrasound and needle biopsy, which confirmed her friends' suspicions. She had breast cancer.

"My husband, Val, and I cried and talked through it and discussed how we would tell our three girls," explains Zweber. She and her husband began the journey of treatment including chemotherapy, lumpectomy, bilateral mastectomy, another round of chemotherapy, radiation and breast reconstruction.

Marti Auringer, RN, BSN, breast care coordinator at St. Francis Cancer Center assisted Zweber every step of the way. "I follow patients from the time of biopsy through their cancer journey," says Auringer. "I'm there for support, from helping to expedite testing results, to working with each patient's primary care physician, following them through surgery and assisting them throughout the continuum of care." In addition, Auringer leads a support group and coordinates classes for patients on dealing with the appearance side effects of chemotherapy.

"The professionals at the St. Francis Cancer Center were phenomenal," says Zweber. "I looked forward to seeing them every other week as if they were family. They were all very compassionate and when you are scheduled for radiation every day for six weeks, it really means the world to have that service ten minutes from your home."

As a breast cancer survivor, Zweber is committed to helping others with the disease. Today, her three girls are 16, 14 and 8. An author of a children's book, *Mommy's Hats*, and a blogger (mommymshats.com), Zweber speaks to support groups and has started a faith-based ministry with a friend at her church called Pink Prayer Warriors.

Don Trimbo: Rehabilitation to remain *independent*

Don Trimbo was just 38 years old when he was diagnosed with peripheral vascular disease.

In July 2010, Trimbo had a leg amputated following his fourteenth surgery since the diagnosis. Trimbo spent the following three weeks at St. Gertrude's Health & Rehabilitation Center where he underwent therapy, which allowed him to walk with assistance and live independently.

"At St. Gertrude's they strengthened my upper body and leg and made sure that I could return to my home," says Trimbo, a resident of East Union just outside of Carver. Since his inpatient stay, Trimbo has returned to St. Gertrude's for outpatient therapy, initially for three times each week.

In early October, Trimbo was fitted with prosthesis and was the first patient at St. Gertrude's to benefit from the new HUR health and fitness equipment, according to Director of Rehabilitation Ed Barron, LPT. The HUR equipment was developed by the University of Technology in Helsinki, Finland and offers therapists the ability to develop highly-customized and safer rehabilitation plans by reducing stress on joints and safely increasing resistance in small increments.

Barron credits the staff, new equipment and Trimbo's hard work and dedication during the rehabilitation process with his progress. "We worked with Don to ensure that he would be able to return home with therapy and family support," says Barron. "He gained enough strength and improved his balance through hard work during his physical therapy. It's beneficial for our patients to offer these services locally, so they do not have to travel very far for their rehabilitative care."

Gifts to the Saints Healthcare Foundation in support of St. Gertrude's Health and Rehabilitation Center have helped to make a new building and specialized equipment possible. "We have the ability to work with patients requiring all levels of rehabilitation, from those recovering from surgery, to the fragile elderly or those who have multiple illnesses," adds Barron.

Along with inpatient and outpatient therapy services, the rehabilitative team at St. Gertrude's prepares patients for life beyond therapy and encourages all patients to continue in a structured wellness or fitness program.

"Exercise is something that people of all ages should be doing," explains Barron.

Today, Trimbo is home enjoying time with his family, especially his grandchildren, and other hobbies including woodworking, football, working on cars and home projects. Trimbo appreciates the care provided by the staff at St. Gertrude's and the encouragement he continues to receive. "It was a good experience to be able to benefit from the equipment and from the care given by Ed, Andy and others," says Trimbo. "I really can't say enough about St. Gertrude's."
