## Making a *Difference* in our Community

Three years ago, the Saints Healthcare Foundation was formed with a mission to assure the necessary resources to support the healthcare needs of the community served by two remarkable organizations.

With a commitment to supporting both organizations, St. Frances Regional Medical Center and St. Gertrude's Health & Rehabilitation Center, the Foundation has strengthened the entire campus with the resources necessary for seamless, compassionate care from birth to end-of-life.

"Patients and family members often tell me how much they appreciate the idea of complete care on one campus," said Mike Baumgartner, President of St. Frances Regional Medical Center. "Once people experience that type of care, they are committed patients and supporters of our health care campus."

Philanthropic support is essential for both organizations as they continue to grow and strengthen services designed specifically for the communities served. "For us, donor support is essential," said Lee Larson, CEO of St. Gertrude's Health & Rehabilitation Center. "Most recently, we were able to add a new 42,000-square-foot addition and building, which would not have happened without the generous support of our community."

According to Baumgartner, support from individuals, corporations and civic groups has helped to ensure that St. Francis has been able to expand services such as cancer care, family birthplace and other critical areas in the hospital. "I

see the Saints Healthcare Foundation as one voice for health care in our community and through it we are able to provide excellent health care services, which today also includes a focus on prevention—on being a partner with individuals to help improve their health. This is a key component of our future and keeping our communities healthy," said Baumgartner.

As an example, Life Time Fitness is now partnering with St. Francis and its employees on health assessments and offering guidance on improving health and wellness. At St. Gertrude's, leaders are planning and looking forward to a future that provides seniors with the tools and support they need to stay in their homes for as long as possible.

"In our business of caring for seniors and others needing rehabilitative care, it's virtually impossible to provide the type of patient care, programming or to enhance services without community support," added Larson. "It is truly a miracle how our community has responded to the mission of Saints Healthcare Foundation. We have significantly improved our ability to accept and care for new patients."

# Local Organizations *support* Healthcare Excellence



Local community and civic organizations have a long history of providing support for St. Francis Regional Medical Center and St. Gertrude's Health & Rehabilitation Center. This support is critical to enhancing services for both facilities and has enabled the organizations to purchase equipment to expand patient services.

Shakopee Rotary has provided philanthropic grants to St. Francis and St. Gertrude's for more than five decades. Chuck Berg, a member of Shakopee Rotary for the past nine years, also serves as the district governor for 62 Rotary clubs in the southern half of Minnesota. "Rotary has been generous to both organizations over the years and we are grateful to make a difference in helping St. Francis and St. Gertrude's purchase equipment to expand patient care."

According to Berg, health care is one area of focus for Rotary. Most recently, Shakopee Rotary contributions were made in support of the St. Francis Cancer Care Coordination.

Another community organization with a strong history of support is Minnesota Valley Electric Cooperative's Operation Round Up—the giving arm of the cooperative. Through an innovative community giving program, members of the Minnesota Valley Electric Cooperative may choose to voluntarily round up their bills each month to the nearest dollar. Since Operation Round-Up's inception, more than \$1.2

million has been donated to various community organizations since 1995.

John Miller has served as a board member of Operation Round Up since 1996 and is currently president of the board. "We have nine very dedicated board members who do a great job of investigating and researching applications," explained Miller. "Throughout the years, we have supported the campus with many grants for worthwhile projects and purchases."

At St. Gertrude's, Operation Round Up has provided grants for its Meditation Room, a television and a Wii gaming system to assist with patient therapy. At St. Francis, grants have been given in support of the Cancer Center for a breast cancer care coordinator, remodeling of diagnostic services, the purchase of ceiling lifts for patients, an ultrasound system, a hearing screening system for newborns and treadmills for cardiac patients.

In addition, St. Francis Regional Medical Center serves as the hospital of choice for Minnesota Valley Electric Cooperative employees. "Everyone I know of who has received care at St. Francis or St. Gertrude's speaks so highly of the campus," said Miller. "I'm so pleased to serve on the board of Operation Round Up—a wonderful organization that continues to step up to the plate to make our community a better place."
